- (5) The Chairman of the Meeting as proxy, need not be a member of the Company.
- (6) The instrument appointing the Chairman of the Meeting as proxy must be under the hand of the appointer or of his attorney duly authorised in writing or, where it is executed by a corporation, be executed either under its seal or under the hand of an officer or attorney duly authorised.
- (7) Proxy forms previously submitted pursuant to the Original AGM Notice dated 24 March 2020 for the AGM scheduled on 23 April 2020 will not be valid for the deferred AGM. Members are requested to submit a fresh proxy form in the manner set out above.
- (8) Submission by a member of a valid instrument appointing the Chairman of the Meeting as proxy must be done not less than 72 hours before the time set for the AGM.

- The Company shall be entitled to reject the instrument appointing or treated as appointing the Chairman of Meeting as proxy if it is incomplete, improperly completed or illegible or where the true intentions of the appointer are not ascertainable from the instructions of the appointer specified in the instrument appointing or treated as appointing the Chairman of the Meeting as proxy (including any related attachment). In addition, in the case of members whose Ordinary Shares are entered against their names in the Depository Register, the Company may reject any instrument appointing or treated as appointing the Chairman of the Meeting as proxy lodged if such members are not shown to have Ordinary Shares entered against under their names in the Depository Register 72 hours before the time appointed for holding the AGM as certified by The Central Depository (Pte) Limited to the Company.
