- (ii) Except Mr Cheng, none of the Non-Executive Directors hold the Company's shares as at the date of this AGM.

- (iii) The Company's Directors and employees who are shareholders of the Company and are eligible to receive shares of the Company under the SBS Executive Share Scheme ("**SBS ESS**"), were required to abstain from voting on Resolution 10 in respect of the adoption of SBS ESS. (d) **RE-APPOINTMENT OF DIRECTORS TO THE AUDIT AND RISK COMMITTEE**

Ms Susan Kong Yim Pui and Dr Tan Kim Siew, who were re-elected as Directors of the Company at the AGM, will continue to serve as members of the Audit and Risk Committee. The Board considers Ms Kong and Dr Tan to be Independent Directors of the Company, for the purpose of Rule 704(8) of the Listing Manual of the SGX-ST.

There is no change to the compositions of the Board and Board Committees.

Key Highlights:

- Revenue ↑ \$32.6m or 2.1% contributed mainly from higher rail revenue from higher ridership and fares
- Operating costs ↑ \$36.1m or 2.5% due mainly to the advertising concession fees payable from 1 January 2024 under the new rail advertising concession agreement and higher staff costs and rail licence charge offset by productivity savings
- Overall PBT ↓ \$4.5m, or 5.1%
- Taxes are lower due to lower profits and writebacks
- Correspondingly, PAT ↑ slightly by \$1.2m or 1.8% due to lower taxes
